- COURT YARD SHALL REMAIN OPEN TO SKY AS SHOWN ON THE DRAWING.
- NO RAIN WATER, SOIL VENTILATING OR ANY OTHER PIPE SHALL BE PERMITTED ON THE EXTERNAL FACE OF ANY BUILDING.

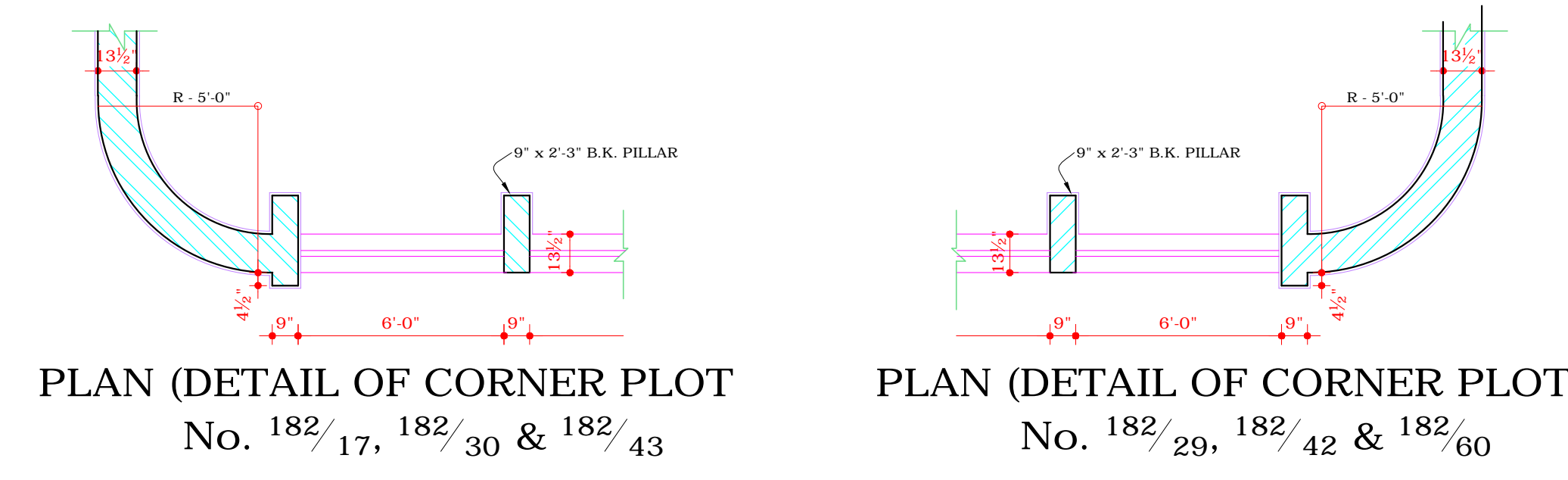
